

Warranty Certificate for EZRAIDER Products

The warranty for the vehicle is for a period of 12 (twelve) months from the date of delivery of the vehicle (subject to the presentation of a delivery certificate or valid invoice).

Subject to the exclusions and limitations described in this vehicle limited warranty, during the warranty period, any component or part in the vehicle that is found to have a defect or fault originating from manufacturing will be replaced or repaired at no cost. It is clarified that inspection, repair, or replacement of a defective component in the vehicle will only be carried out at authorized repair facility as detailed on the manufacturer's website.

Tires, bulbs, fuses, plastic parts, and consumable parts are not included in the vehicle limited warranty unless there is a defect originating from the vehicle manufacturer.

the manufacturer hereby disclaims and will not be responsible for any direct, indirect, incidental, special, consequential damages and/or losses, caused as a result of using the vehicle, including, without limitation, bodily injuries, incidental charges, personal or property damage, loss or theft of the vehicle, economic losses, loss of time, loss of income, emotional distress or harm, inconvenience, aggravation, or any other reason.

The above limitations and exclusions shall apply whether your claim is in contract, tort (including negligence and gross negligence), breach of warranty or condition, misrepresentation (whether negligent or otherwise) or otherwise at law or in equity, even if the manufacturer is advised of the possibility of such damages or such damages are reasonably foreseeable.

The warranty does not cover any vehicle damage or malfunction directly or indirectly caused by, due to or resulting from normal wear or deterioration, abuse, misuse, negligence, accident, improper maintenance, operation, storage or transport, including but not limited to, any of the following:

1. Failure to take the vehicle to, or make repairs or service authorized, by the manufacturer or manufacturer's authorized repair facility upon discovery of a defect covered by this limited warranty certificate.
2. Any repair, alteration or modification of the vehicle that was made inappropriately, or the installation or use of fluids, parts or accessories, was made by a person or facility not authorized or certified to do so or without the manufacturer's approval.
3. Nonperformance of, or failure to perform periodic maintenance in accordance with the user manual documentation.
4. Improper repair or maintenance, including use of fluids, parts or accessories other than those specified in the user manual documentation.
5. Fire, explosion, earthquake, windstorm, lightning, hail, flood, or deep water.
6. Theft, vandalism, riot, accidents, collisions, water damages or objects striking the vehicle.
7. Non-genuine parts or accessories or their installation, or any damage directly or indirectly caused by, due to, or resulting from, the installation or use of non-genuine parts or accessories.
